Mazaraki A., Melnyk T. Modern trends and factors of foreign trade development in Ukraine. The article considers trends and factors of foreign trade development in Ukraine. It researches the changes of visible export-import structure; the influence of crisis on foreign trade is analyzed. Special factors which not only influence the export flows and import arrivals but also determine the direction of their changes in perspective, are outlined.

Korolchuk O., Cherepov V. Optimization of commercial communications of trade enterprise. The article develops methodical approaches to optimization of commercial communications of trade enterprise. The structure and properties of commercial potential of trade enterprise are characterized. Indicators for estimation of economic efficiency of commercial communications under risk are defined. Techniques of the accounting of some market situations in optimization of commercial communications of trade enterprise are offered.

Lazebna I. Formation of competitive environment in retail trade. The article researches economic contents of competitive environment in goods turnover sphere, the conditions of its formation, main development trends. The central part of the consumer goods turnover sphere – retail trade – is analyzed. The modern conditions of retail goods turnover development in Ukraine are researched.

Yermoshenko A., Yermoshenko L. World experience of dispute resolution authorities' activity in financial sphere. The article researches the key components of functioning of bodies of financial services consumers' complains consideration, in particular, the Financial Ombudsman Service in Great Britain as integrated and one of the most progressive organizations in this sphere. There are presented the main characteristics of dispute resolution authorities' structures. The procedure steps of disputes resolution between financial services consumers and financial institutions are substantiated.

Kucher G. Development of internal debentures market in Ukraine. The article analyzes the interdependence of the internal and external borrowing policy, influence of situation on international markets on the volumes of borrowing on the internal market of debentures. The features of functioning of primary and secondary market of public bonds are exposed. The trends and prospects of internal debenture market development in Ukraine are defined.

Zimovskaya L. Some aspects of pension system formation in Ukraine. The article considers the essence of the pension system, its components and place in the social security system. The effect of the financial crisis on pension insurance is analyzed. The problems of the budget formation of the Pension Fund of Ukraine are outlined.

Marchyuk V., Myronets I. Construction activity licensing. The article considers the licensing procedure as a part of administrative and law regulation of relations in construction business. The practical moments of law application are analyzed; the theoretical grounds of the institution of business activity in construction business licensing are researched. The issues of getting the license by foreign subjects and other actual moments in the construction activity licensing sphere are considered.

Reguretska O. The procedure of shares restoration under Ukrainian law. This article analyzes the legal notions "mortification" and "amortization" which

were investigated in the late XIX – early XX century, as well as the modern notion "renovation" of shares. It also researches the procedure of shares renovation in case of their loss, actions to be done by the owner of the shares for lost shares renovating as well as the documents to be submitted to the registrar to renew the certificate of shares.

Lata N. Legal aspects of foreigners' employment in Ukraine. This article researches the peculiarities of employment of foreigners and people without citizenship in Ukraine. The order of work permit obtaining for foreigners and the list of documents to be submitted are analyzed. The features of the work permit prolongation and the order of its canceling are considered.

Shkepu M. Ethnic peculiarities of formation of cultural time space in classical establishment of the basis of the history. The article considers some features of evolution of social and cultural measures of time space of the history in the context of its classical establishment. There has been proven that essential basis of such evolution is the establishment of such forms of production and vital functions of certain nations and humanity as a whole, which stipulated the establishment of essential (practical and theoretical) strengths of the humanity in unity with its possibility to allocate the nature of social and historical development categorically.

Skulovatova O. The theme of fate in the concepts of psychoanalytical direction. The article researches the understanding, interpreting and meaning of the fate in the works of psychoanalysis classics. Classic theories of psychoanalysis don't consider the fate as a separate aspect of the unconscious problem, or archetype, but the apologetes couldn't ignore it as well. Its importance attracts attention and is realized in their theoretical research, in which the fate is the factor of the person's walk of life.

Prytuliak P. Ukrainian foreign trade after Brest Peace signing. On the basis of the archive materials the article analyzes little known facts about quantitative indicators of imports and exports between Ukraine and the countries of Central Europe in the period of the activity of the Ukrainian Central Council and Hetman government of Pavlo Skoropadskiy.

Andriychuk M. National issue in Naddniprovyanshyna's social-democratic periodicals in the early XX century. The article analyses Naddniprovyanshyna's periodicals of social-democratic organizations in Ukraine in early XX century; it reflects their vision of the national issue in the Russian Empire and ways to solve it. Newspapers' editorial staff such as "Trud" and "Slovo" reflected in their publications not only important components of national issues such as Ukrainian and Jewish issue but also participated in discussion held on the pages of Naddniprovyanshyna's periodicals.

Yakubenko V., Berling R. Problems and perspectives of adult education in Ukraine. The article analyzes the problems of adult education development in Ukraine. It substantiates that qualitative level of adult education depends on many factors, i.e. on education level gained, level of expertise and professional skills, basis of professionalism, display of cognitive and professional interests, integrity of general and vocational education. The range of measures for further improvement of education in Ukraine has been offered.
