Mazaraki A., Melnik T., Izobim B. Light industry of Ukraine: state, problems of visible export and import. Trends and factors of Ukrainian light industry's development are considered. Quality indices of light industry production, profit formation, structure of commodity resources and their use in this type of activity are investigated. Factors influencing formation of export-import commodity streams of industry on the modern stage of Ukrainian economy's development are distinguished. Measures to improve the state of light industry of Ukraine are grounded.

Umantsiv Y. Corporate structures in the system of economic relations. The article analyzes some aspects of the economic nature of corporate structures. The theoretical approaches to the analysis of the corporate structures economic essence are generalized. The main types and key characteristics of corporate structures are determined. The corporate structures role in the economy of Ukraine is analyzed.

Sunduk A. Influence of the world business processes on the social-economic system's development. The article reveals the theoretical and practical aspects of research of the features of social-economic systems in Ukraine in the context of the world processes influence. It offers the main characteristics of social and economic systems functioning in the context of interaction with these processes. The main directions of exogenous processes and social and economic systems of Ukraine interaction are determined.

Chaika Yu. Mechanisms of national economy's structural development. The theoretical mechanism of economic system structure development is analyzed; its principal subsystems and elements are determined; the algorithm of their research is offered. The construction, the main contradiction, and the functions of the mechanism of the Ukraine's economy structure development are characterized. Objectives, factors and objective laws of structural changes are defined.

Mykytiuk I. Risks estimation in the system of internal financial control. The article considers theoretical and methodological foundations of risks management and analysis as a functional mechanism of efficiency and quality of financial control increase in the activity of controlling bodies. The circumstances and reasons of risks emergence in the process of formation and use of the budget funds are analyzed. The main tasks of controlling bodies and basic principles of risks management in the sphere of the state finance are determined.

Makogon V. Modern budgetary policy priorities of Ukraine. The article researches the problems of budget policy use as a component of the system of financial regulation of social and economic development of the country. The role of the budgetary policy as an instrument of social and economic development of the society is determined. The measures to increase efficiency and productivity of the budget management are offered.

Suvorov V. Evaluation of effectiveness of Ukraine customs authorities' fiscal function. The article analyzes the main indicators of customs authorities' activity in the sphere of tax and dues collection. Factors that influence the customs payment volume are determined. The system of indicators allowing appreciating separate components of customs authorities' effectiveness performing fiscal function is offered.

Erkes O. The anticrisis management as an instrument of bank's soundness improvement. The article researches the mechanism of anti-crisis bank management in Ukraine as a process of restoring normal operational activity of the institutions under both systemic crisis and crisis in individual bank. The criteria of crisis overcoming by bank institutions are considered; the main directions of financial and economic rehabilitation as well as the subjects of this process are determined.

Beliakova V. Information base of credit relations efficiency. The article considers alternative sources rather than equity which can be used to finance the activities of the economic entities are considered. An analytical assessment of their information provision in accounting and financial reporting is carried out; the mechanism of coordination of interests of interested parties under credit relations realization is determined.

Orlenko V. Orlenko L. Evolution of rights and freedoms of the human being. The article analyzes the main stages of formation and evolution of human rights since the ancient times up to nowadays. Four generations of human rights are defined. The conclusion is made that human rights are an indicator which allows applying "human measure" not only to the state, law but also to the civil society.

Krasilich N. Problems of commercial (trade) law development in Ukraine. The article considers features of development and formation of commercial (trade) law in Ukraine. The problems of legal nature of commercial (trade) law, its place in the legal system and correlation with other branches of law are researched.

Statinova N., Kushchenko O. Priorities and valuables of modern students. The article analyzes the research results of spiritual and moral guiding lines of the students of Kyiv National University of Trade and Economics. It was determined that value priorities of the students change with the course of study. The importance of sociological research in the organization of educational process is determined.

Zakharova T. Private property in the modern Ukrainian society: sociological dimension. The article considers the sociological problems of the private property in Ukraine which has become the result of realization of the state's privatization course. Based on the sociological polls results, the subjective perception by the people of institutional private property in the society is analyzed. The main stages of Ukrainian privatization process and its contradictive social consequences are also examined in the article.
